Santasport Institute's development work in safety

- We have had projects in this thema since 1998.
- T.O.P.S.I.E Training Opportunities in Europe 1998 2001 (Leonardo)
- Towards international adventure and programme services 2005-2007 (Leader+), partners were from Austria, Tirol
- Santasport Institute made the safety analysis of tourist resorts in Lapland, which was
 commissioned by the Ministry of the Interior and conducted in 2002, revealed the
 need to develop a brief safety training programme aimed at travel industry workers.
 It was decided that the main goals of the training would be prevention and
 attitude development.

⇒ three years project 2005-2007 ⇒ Travel industry Safety Passport

- Numerous travel industry entrepreneurs, workers, educational institutes, authorities and representatives of travel organisations took part in developing the passport.
- The national Internal Security Programme listed the development of the safety passport project as one of its aims.
- The Travel Industry Safety Passport project led by the Santasport Institute produced a training concept that includes a curriculum as well as materials for course leaders and students.

The textbook is in finnish, swedish, russian and in english.





The primary task of the Finnish National Rescue Association is registration and information provision in relation to passport training. The Santasport Institute carries the main responsibility for the training of the course leaders and the development of the teaching materials.

- The training of **the course leaders** is 2 days
 137 persons have been certificated
- Travel industry Safety Passport, one day training, has been kept 382 times
 - 201 times in North of Finland
 - 103 in Middle of Finland 77 in South of Finland
 - 1 out of Finland

5044 have done passport

Travel industry Safety Passport is inside the vocational education of travel industry (in Finland), Physical Education and Outdoor activities

- about 400 students per year study Travel industry Safety Passport training program, but everyone is not in register
- Travel industry Safety Passport is also inside the further education of ski instructors (ISIA)

The qualification criteria for course leaders

The following qualifications are required to apply for the training for Travel Industry Safety Passport course leaders:

- 1. A strong background in the travel industry and experience in providing customer
- service to tourists
- 2. Experience in training
- 3. Active interest in safety issues
- 4. A previously completed and effective Travel Industry Safety Passport Training
- 5. Sufficient skills and tools for utilising electronic training materials and managing
- course information and records
- 6. A successfully completed preliminary assignment

The course leader qualification is effective for five years from the month in which the training is completed.

The Travel Industry Safety Passport Committee is responsible for developing the training. The committee monitors the training sessions to ensure that their content and programme adhere to this guide. The quality of the training is monitored by means of national analyses and individual pieces of customer feedback.

The Travel Industry Safety Passport Committee organises occasional safety passport course evaluations. These entail evaluators authorised by the committee attending and evaluating the courses held by various organisations. The evaluators report to the Travel Industry Safety Passport Committee.

- we had also project to develop **Ski Patrol** education in Finland. The first pilot education was too massive or heavy (40 days) to finnish cirtumstances (years 2008-2010), but we learned....
- Next step was to develop education really together with Finnish Ski Area Association, now we have 3 modules, all together 10 days, for Ski Patrol:
 - 1. Travel industry Safety Passport, Safety risks at skiresorts and preventation, Safety documents for ski resort services, First aid at ski areas
 - 2. Lift rescue, hypotermic and how to handle it, independent action in emergency cases and at rescue situations
 - 3. "Snow safety", safety risks and preventation, equipments, off-piste skiing/moving, rescue and how to organize rescue situation

during 2012 – 2013 all Ski resorts from North of Finland took part in education and partly from other finnish areas

- 44 persons were on 1. module
 24 persons have done all 3 modules
- Snow safety education (the 3. module)
 - o to ski instructors
 - to lift and slope workers at ski resorts
 - to officials of municipalities

What else:

Partnership agreement with Ministry of the Interior in 2010

- Safety first - Internal Security Programme 2008 - 2011

Basicly it's the promise to develop safety in the Travel Industry and in the Physical Education and the safety of circumstances

The Government adopted the third Internal Security Programme on 14 June 2012. We are also updating the agreement – this year 2013 together with MTI
