



The aim of the Internal Security Programme

The goal of the National Internal Security Program

The purpose of the Security Program is to improve security in everyday life and effectively address problems that undermine the security of society or people's sense of security



Laplans regional Working method:

1. To support municipalities and local actors,
2. Co-ordinate the aims of the internal Safety Program to the other National, regional and local strategies and programs,
3. Improve regional and local co-operation between authorities and NGO's,
4. Improve preventive work,
5. To offer to the NGO's better possibilities to act and support them
6. To strength safety level and safety hospitality in local enterprices,
7. Identify and remove safety risks,
8. Improve the efficient use of the common resources.

- Efficient use of the common resources**





SOME EMERGENCY SITUATIONS IN LAPLAND

YEAR	EVENT	INFLUENCE
1983	Mauri storm	2 dead, large damages
1986	Tšernobyl nuclear accident	
1994	Turistbuss accident / Enontekiö	Bussi to the river, 30 person, - 25 C
1999	Extremely cold period	Problems with transport, infrastructure
2000	Pyhäntunturi water epidemic	2.200 be exposed, 300 fallen ill
2005	Turistibuss accident/ Keminmaa	1 dead, 15 injured
2005	Bird influenza	Large prevention to pandemia
2005	Dogsled accident / Tornio	2 dead, large media interest
2006	Fire in Holet Pallas	Large economical losses
2006	Fire in Kittilä Airport	No air traffic
2009	Vide telecommunication lacks	Salla 7,5 h without telecommunication
2010	H1N1 influenza	Large prevention to pandemia
2010- 11	Vide telecommunication lacks	Several municipalities without telecommunication
2010	Ash cloud from Island	Hundreds of travellers without flight back home


