




The location of Ireland within Europe






Determinants of Health





Determinants of Health



Vision:

where everyone can enjoy physical and mental health and wellbeing to their full potential, where wellbeing is valued and supported at every level of society and is everyone's responsibility.





Healthy Ireland Goals

1. Increase the proportion of people who are healthy at all stages of life
2. Reduce health inequalities
3. Protect the public from threats to health and wellbeing
4. Create an environment where every individual and sector of society can play their part in achieving a healthy Ireland



Emergency Management

- 15 WTEs
- Budget €7.7m
- Supports all HSE managers in preparing for, and responding to, Major Emergencies
- Manages the interagency Emergency Management agenda
- Responsibility for regulatory functions in the areas of planning for Crowd Events and the Seveso Directive
- Comprises a National office and offices in each of the 4 HSE regions

Emergency Management

- Created as a National service in 2006
- Developed “A Framework for Major Emergency Management” with other Principle response agencies in 2006
 - Ongoing management
- Developed National and Regional Crisis management plans 2008
 - Regularly reviewed
- Coordinated development of Ireland’s National Pandemic Plan-2007-2010
 - Currently being updated
- Supported HSE response to severe weather episodes in recent years
- Developed HSE protocol for Large Crowd Events 2013






Vision

- *“Local government will be the main vehicle of governance and public service at local level - leading economic, social and community development, delivering efficient and good value services, and representing citizens and local communities effectively and accountably”*

Big change!

- Unification of city & county councils
- Town councils replaced by municipal structures
- Elected members will decide local matters at district level
- Local service – locally funded through property tax
- Enhanced role of economic development

Regional Structures up to May 2014




8 Regional Authorities [NUTS 3]




2 Regional Assemblies [NUTS 2]

New Regional Structures




Existing Regional Assemblies in place for transition period from June 1st to December 31st 2014



Key Challenges / Opportunities


- Tradition of a fragmented approach to public service delivery – multitude of agencies with narrow range functions
- Inconsistency of regional boundaries among different agencies/sectors.
- Need for more co-ordinated, inter-agency model and ‘whole of society’ approach e.g. Local government services, Health, Education, Community & Voluntary sector etc.

Key Challenges / Opportunities


- Examine new & innovative ways of working together to provide for more effective public service delivery

- Potential opportunities to fund initiatives under EU Operational Programme 2014-2020




